3.3. Building Program

- The Vision for Learning Program has a significant part in the planning process
- A concept plan will be presented to the community for future buildings to accommodate the learning strategies.

- A query was raised regarding parents having access to comment on plans before they are finalised. The school agreed that plans presented would be concept plans and open to comment.

4. Counselling

- Psychology services will be reviewed this year
- Leaders for Wellbeing role has a broader responsibility to support students in times of need
- Query raised as to whether psychology service across the school was sufficiently resourced with the departure of Jackie Cesareo. School response was that the Wellbeing Plan was in development, but that Denise has increased her time to cover the primary school needs, in addition to her existing work in the secondary school. When further questioned if this was sufficient resourcing, the school responded it was and that no appointments would be made to this area until the Wellbeing Plan has been reviewed and completed.

5. Nature Play

- Discussion regarding temporary spaces for children
- Representatives would like to work with the relevant people to accommodate their visions into future plans
- Mitch has been meeting with representatives from staff, parents and professionals to get some processes in place
- Parents are concerned about the lack of sports equipment and playground rosters | usage for students
- Parents are concerned about the provisions for students and the bullying that results as a 'knock on affect'
- The College advises that they are investigating the issues
